## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** ALAN A. HAGA

of Route 1, Box 1553, Bandon, State of OR 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willow Creek and Floras Creek

a tributary of New River for the purpose of irrigation of 199.2 acres and supplemental irrigation of 106.5 acres

under Permit No. 41316 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 3, 1976 for Floras Creek and February 22, 1977 for Willow Creek that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.88 cubic feet per second; being 0.48 cfs from Willow Creek and 1.4 cfs from Floras Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, Section 9, SE 1/4 SE 1/4, Section 5, SW 1/4 SW 1/4, Section 4, T31S, R15W, WM; Diversion No. 3 - 1300 feet South and 3960 feet East; Diversion No. 1 - 600 feet North and 1140 feet West; Diversion No. 2 - 1000 feet North and 110 feet East all from NW corner Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
