CERTIFICATE OF WATER RIGHT

This is to Certify, That SAMUEL LONEY

of Walla Walla, State of Washington has a right to the use of the waters of Pine Creek, for Tract #1; and Schwartz Spring Branch, a tributary of Pine Creek, for Tract #2; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 7, at page 148; that the priority of the right thereby confirmed dates from 1874;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed One acre foot per acre during any thirty-day period nor three acre feet per acre during the irrigation season beginning April 1st and ending Oct. 1st, from Pine Creek for Tract #1; and One-eighth of one cubic foot per second per acre from Schwartz Spring Branch for Tract #2. A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1. (Irrigated from Pine Creek)

Ten and four tenths (10.4) acres in the Northeast Quarter of the Southeast Quarter (NE1/4SE1/4); Six and four tenths (6.4) acres in the Northwest Quarter of the Southeast Quarter (NW1/4SE1/4); Twelve (12) acres in the Southwest Quarter of the Southeast Quarter (SW1/4SE1/4) and Thirty-three and four tenths (33.4) acres in the Southeast Quarter of the Southeast Quarter (SE1/4SE1/4) of Section Seventeen (17), Township Six (6) North, Range Thirty-four (34) East of the Willamette Meridian, containing 62.2 acres.

Tract #2. (Irrigated from Schwartz Spring Branch)

Seven and nine tenths (7.9) acres in the Southwest Quarter of the Northeast Quarter (SW1/4NE1/4); Thirteen and seven tenths (13.7) acres in the Southeast Quarter of the Northeast Quarter (SE1/4NE1/4); Twenty-four and three tenths (24.3) acres in the Northeast Quarter of the Southeast Quarter (NE1/4SE1/4) and Nineteen and seven tenths (19.7) acres in the Northwest Quarter of the Southeast Quarter (NW1/4SE1/4) of Section Seventeen (17), Township Six (6) North, Range Thirty-four (34) East of the Willamette Meridian, containing 65.6 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
