CERTIFICATE OF WATER RIGHT

This is to certify, ThatGALICE SUBDIVISION WATER COMPANY
c/o Merle Johnson

of 12143 Galice Road, Merlin, State of OR 97532, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Rock Gulch

a tributary of Rogue River for the purpose of domestic use for 18 families, domestic use at 3 camp trailer sites and irrigation of 4.2 acres under Permit No. 40733 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 4, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second; being 0.05 cfs for irrigation and 0.03 cfs for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, as projected within J. Steel Mine Claim 40, Section 35, T34S, R8W, WM; 800 feet South and 90 feet West from NE corner Section 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Camp Trailer & Domestic & 1.7 acres Lot 13 (SW 1/4 NW 1/4)
Camp Trailer & Domestic & 1.3 acres Lot 14 (SE 1/4 NW 1/4)
Camp Trailer & Domestic & 1.2 acres Lot 8 (NE 1/4 SW 1/4)
Section 36

Township 34 South, Range 8 West, WM

Land upon which water used more explicitly described as:

Domestic & Block 1 - Lots 7, 8, 10, and 11
Irrigation Block 2 - Lots 3, 5, 6, 7, 8, 10, and 14
Block 3 - Lots 3, 4, 5, 6, 8, 10, and 11

Camp Trailer & Block 2 - Lots 4, 11
Irrigation Block 4 - Lot 8

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
