under Permit No. G-6876 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

13.5 cubic feet per second; being 5.5 cfs from Well #1. 2.8 cfs from Well #2 and 5.2 cfs from Well #3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NE 1/4, Section 10, T4N, R25E, WM; Well #1 - 1300 feet North and 440 feet West; Well #2 - 1250 feet North and 100 feet West both from E 1/4 corner Section 10; Well #3 - 1430 feet South and 1120 feet West from NE corner Section 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of these wells, the quantity of water allowed herein together with the right perfected under Certificate 51782 shall not exceed 13.5 cubic feet per second, the capacity of this well system \* and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

\*at the time of perfection of this right, and shall be limited to the appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.
