CERTIFICATE OF WATER RIGHT

This is to certify, That PERRY H. PRICE

of Route 3, Box 147R, Milton-Freewater , State of OR 97862 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of a branch of Cold Springs Creek (Walla Walla River) for the purpose of irrigation of 2.0 acres

under Permit No. U=288 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.025 cubic foot per second, if available at the original point of appropriation in the NE 1/4 SW 1/4, Section 24, T6N, R35E, WM; 10 chains North and 9.3 chains West from SE corner NE 1/4 SW 1/4, Section 24.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 SW 1/4, Section 24, T6N, R35E, WM; 810 feet North and 290 feet West from SE corner NE 1/4 SW 1/4, Section 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres NE 1/4 SW 1/4
Section 24
Township 6 North, Range 35 East, WM

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered February 26, 1979, and together with certificate of water right recorded at page 47768, Volume 41, State Record of Water Right Certificates, supersedes certificate 27123.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
