CERTIFICATE OF WATER RIGHT

This is to certify, That LOYALTA CORPORATION

of Route 3, Box 3268, Hermiston, State of OR 97838, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well #2

a tributary of Umatilla Basin for the purpose of irrigation of 158.4 acres

under Permit No. G-2291 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 7, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.13 cubic feet per second, if available at the original point of diversion in the NW 1/4 NE 1/4, Section 29, T4N, R29E, WM; Well #1 - 1280 feet South and 2620 feet West from NE corner Section 29.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NW 1/4, Section 29, T4N, R29E, WM; Well #2 - 1050 feet North and 640 feet West from Center 1/4 corner Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

40.0 acres NW 1/4 NE 1/4 40.0 acres NE 1/4 NW 1/4
39.2 acres SW 1/4 NE 1/4 39.2 acres SE 1/4 NW 1/4

Township 4 North, Range 29 East, WM

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered November 5, 1985, and supersedes certificate of water right recorded at page 37354, Volume 29, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
