CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HORSESHOE IRRIGATION DISTRICT AND
C.A. HUBBARD

of Box 776, Pendleton, State of OR 97801, has
a right to the use of the waters of Umatilla River

a tributary of Columbia River for the purpose of
irrigation of 65.0 acres, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Umatilla County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 3, at page 127; that the priority of the
right thereby confirmed dates from December 26, 1904

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.81 cubic foot
per second, subject to the provisions of paragraph 33 of said decree

The point of diversion is located in the SW 1/4 SE 1/4, Section 2, SE 1/4 SE 1/4,
Section 3, T2N, R30E, WM

A description of the place of use under the right, and to which such right is appurtenant, is as

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 35280, Volume 27, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on September 19, 1986 approving Transfer application 5773.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
