CERTIFICATE OF WATER RIGHT

This is to certify, That JOHNSON WATER & SEWAGE SYSTEM, INC

of 8000 SE Roots Road, Milwaukie, State of OR 97222, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Kellogg Creek and a reservoir to be constructed under Permit R-5439

a tributary of Willamette River for the purpose of irrigation of 33.2 acres and recreation

under Permit No. 34205 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 15, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second; being 0.42 cfs for irrigation and 0.10 cfs for recreation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4, as projected within Cranfield DLC 49, Section 8, T2S, R2E, WM; 730 feet North and 230 feet West from SW corner Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.8 acres Lot 7 (SE 1/4 SE 1/4)
14.8 acres SE 1/4 SE 1/4 as projected within Cranfield DLC 49 Section 8
5.7 acres SW 1/4 SW 1/4 as projected within Cranfield DLC 49 Section 9
8.0 acres NW 1/4 NW 1/4 as projected within Cranfield DLC 49 Section 16
1.9 acres NE 1/4 NE 1/4 as projected within Cranfield DLC 49 Section 17
Township 2 South, Range 2 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
