## CERTIFICATE OF WATER RIGHT

This is to certify, That

GARY LEE SAMBUCETO

OR 97013 of 8550 S. Lone Elder Rd., Canby , State of , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well with any deficiency in the available supply of water from the well to be made up by diversion from a sump Gribble Creek for the purpose of a tributary of

irrigation of 25.2 acres

and that said right to the use of said waters has been perfected in G-8532 under Permit No. accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 15, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is ocated in the SW 1/4 SE 1/4, NW 1/4 SE 1/4, Section 9, T4S, R1E, WM; Well - 200 feet North and 2050 feet West; Sump - 1970 feet North and 2350 feet West both from SE corner Section 9.

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from April 1 to September 30 and shall be further limited to a diversion of not to exceed l acre foot per acre for each acre irrigated during the period of October l to March 31, provided further that the right allowed herein shall not exceed 2.5 acre feet for each acre irrigated in any one year. The use allowed herein may be made anytime between October 1 and March 31 when water\* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is 8.7 acres NW 1/4 SE 1/4 appurtenant, is as follows:

16.5 acres SW 1/4 SE 1/4 Section 9 Township 4 South, Range 1 East, WM

\*can be put to beneficial use by irrigation for immediate crop growth. The use of water during the period from October 1 to March 31 as authorized herein shall not establish priority of right against future appropriation of ground water for beneficial uses other than similiar rights for irrigation from October 1 to March 31, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
