under Permit No. 38164 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.01 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4, SE 1/4 NE 1/4, both as projected within J. Putman DLC 38, Section 16, T22S, R6W, WM; 1-770 feet North and 1150 feet East; 2-100 feet North and 1980 feet East; 3-200 feet North and 1980 feet East; all from C 1/4 corner Section 16; Dam -940 feet North and 1630 feet West from E 1/4 corner Section 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
