CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* ROSEBURG LUMBER COMPANY

of PO Box 1088, Roseburg, State of OR 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Cow Creek

a tributary of South Umpqua River for the purpose of industrial use during the irrigation season only

under Permit No. 11951 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 25, 1935 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second, if available at the original point of diversion; SE 1/4 SE 1/4, Section 23; NW 1/4 SW 1/4, Section 24; NE 1/4 NE 1/4, Section 26, T30S, R6W, WM; 530 feet North and 140 feet West; 2150 feet North* or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, as projected within Catching DLC 43, Section 26, T30S, R6W, WM; 5710 feet South and 20 feet East from NW corner Flint DLC 45.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

*and 750 feet East; 650 feet South and 980 feet West; all from SE corner Section 23

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in place of use, point of diversion and use approved by an order of the Water Resources Director entered June 23, 1978, and supersedes certificate of water right recorded at page 19946, Volume 14, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
