## CERTIFICATE OF WATER RIGHT

under Permit No. 6612 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1924

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second, if available at the original point of diversion; NW 1/4 SW 1/4, Section 24, T30S, R6W, WM; 660 feet South and 480 feet East from W 1/4 corner Section 24

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, as projected within Catching DLC 43, Section 26, T30S, R6W, WM; 5710 feet South and 20 feet East from NW corner Flint DLC 45.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to —————— of one cubic foot per second per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer.
