## CERTIFICATE OF WATER RIGHT

and that said right to the use of said waters has been perfected in 15664 under Permit No. accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 16, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is

limited to an amount actually beneficially used for said purposes, and shall not exceed

0.018 cubic foot per second, if available at the original point of diversion;

Lot 3 (NE 1/4 SE 1/4), Section 16, T34S, RlW, WM; 790 feet South and 360 feet

West from E 1/4 corner Section 16

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of liversion is located in the Lot 3 (NE 1/4 SE 1/4), Section 16, T34S, R1W, WM; 1130 feet South and 800 feet West from E 1/4 corner Section 16. diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second per existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season fom April 2 to October 31 of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres Lot 3 (NE 1/4 SE 1/4) Section 16 Township 34 South, Range 1 West, WM

by an order of the Water Resources Director entered March 30, 1977, and together with certificates of water right recorded at pages 44949, & 48451, Volumes 37, & 41, State Record of Water Right Certificates, supersedes certificate 19511. This certificate is issued to confirm a change in point of diversion approved

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
