CERTIFICATE OF WATER RIGHT

This is to certify, That EDWARD DRESCHER

of 34224 S. Meridian Road, Woodburn, State of OR 97071, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Senecal Creek for the purpose of irrigation of 93.4 acres

under Permit No. G-8169 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 20, 1978 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.90 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NE 1/4, as projected within Bonenfant DLC 43, Section 27, T5S, R2W, WM; 20 feet South and 1150 feet East from NW corner Poujade DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

18.0 acres NE 1/4 NE 1/4 as projected within Bonenfant DLC 43
 24.0 acres NW 1/4 NE 1/4 as projected within Bonenfant DLC 43
 1.2 acres Lot 2 (NW 1/4 NE 1/4)
 20.8 acres SW 1/4 NE 1/4 as projected within Bonenfant DLC 43
 10.6 acres SW 1/4 NE 1/4 as projected within Poujade DLC 44
 9.6 acres SE 1/4 NE 1/4 as projected within Bonenfant DLC 43
 0.6 acre NE 1/4 NW 1/4 as projected within Bonenfant DLC 43
 3.0 acres SE 1/4 NW 1/4 as projected within Bonenfant DLC 43
 5.2 acres SE 1/4 NW 1/4 as projected within Poujade DLC 44
 0.4 acre NW 1/4 SE 1/4 as projected within Poujade DLC 44
