## CERTIFICATE OF WATER RIGHT

**This is to certify, That**VICTORIO LAND & CATTLE COMPANY  
AND TRAVELERS INSURANCE COMPANY

2621 E. Camelback Road, Suite 175, Phoenix AZ 85016  
of 707 SW Washington, Portland, State of OR 97205, has made  
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of  
Wells 1, 2, 6

a tributary of Sheep Creek for the purpose of  
supplemental irrigation of 192.8 acres, feed lot and feed mill

under Permit No. G-5269 and that said right to the use of said waters has been perfected in  
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from  
June 6, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is  
limited to an amount actually beneficially used for said purposes, and shall not exceed

1.75 cubic feet per second; being 0.02 cfs for feed mill from Well 1; 1.3 cfs  
for supplemental irrigation from Well 2 and 0.43 cfs for feed lot from Well 6

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is  
located in the NE 1/4 NE 1/4, NE 1/4 NW 1/4, Section 21,  
T19S, R46E, WM; Well 1 - 1160 feet South and 2480 feet East; Well 2 - 1200  
feet South and 4930 feet East; Well 6 - 1080 feet South and 2430 feet East;  
all from NW corner Section 21.

The amount of water used for irrigation, together with the amount secured under any other right  
existing for the same lands, shall be limited to one-eightieth of one cubic foot per second  
per acre,

or its equivalent for each acre irrigated and shall be  
further limited to a diversion of not to exceed 3.0 acre-feet per acre for  
each acre irrigated during the irrigation season of each year, provided  
further that the right allowed herein shall be limited to any deficiency in  
the available supply of any prior right existing for the same land and shall  
not exceed the limitation allowed herein,

and shall  
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is  
appurtenant, is as follows:
