and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 252; that the priority of the right thereby confirmed dates from 1904

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.30 cubic feet per second from March I to July I and 3.65 cfs from July I to October I of each year; the total quantity diverted during each irrigation season not to exceed 730 acre feet, if available at the original point of diversion in the\*

The point of diversion is located in the SE 1/4 SW 1/4, Section 19, T7S, R38E, WM; Mansfield Ditch - 1310 feet North and 2310 feet East from the SW corner Section 19.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
