## CERTIFICATE OF WATER RIGHT

**This is to certify, That** L.E. VON DERAHE

of Box 745, Milton-Freewater, State of OR 97862, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Walla Walla River for the purpose of irrigation of 43.0 acres

under Permit No. U-447 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 13, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.538 cubic foot per second, if available at the original point of appropriation in the NW 1/4 NW 1/4, Section 31, T6N, R36E, WM; 510 feet South and 150 feet East from NW corner Section 31.

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NW 1/4, Section 31, T6N, R36E, WM; 320 feet South and 510 feet East from NW corner Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.0 acres SW 1/4 SW 1/4	36.0 acres NW 1/4 NW 1/4
Section 30	Section 31
Township 6 North, Range 36 East, WM	

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered June 11, 1980, and supersedes certificate of water right recorded at page 22881, Volume 16, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
