CERTIFICATE OF WATER RIGHT

This is to certify, That LEON A. REESE

of Route 2, Box 16, Echo , State of OR 97826 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Stage Gulch irrigation of 118.3 acres

for the purpose of

under Permit No. G-4955 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 2, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.7 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 SW 1/4, Section 22, T3N, R30E, WM; 820 feet North and 940 feet East from SW corner Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with the right perfected under Permit G-8633 shall not exceed 1.34 cfs, the capacity of this well at the time of perfection of this right.

Conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.8 acres NE 1/4 SW 1/4 39.6 acres NW 1/4 SW 1/4

38.2 acres SW 1/4 SW 1/4 19.7 acres SE 1/4 SW 1/4

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered May 14, 1979, and supersedes certificate of water right recorded at page 44777, Volume 36, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
