of 1527 E. 18th The Dalles , State of OR 97058 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fifteenmile Creek

a tributary of Columbia River supplemental irrigation of 209.5 acres

for the purpose of

under Permit No. 44816 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

November 21, 1979 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.6 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 30, T1S, R14E, WM; 980 feet North and 310 feet East from W 1/4 corner Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further, that although declared herein to be for supplemental irrigation, the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply, provided further that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein,*

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

*and provided further that this right, together with the right described under Certificate 50933 (Permit 5288), shall not exceed 2.6 cfs, the capacity of this system at the time of perfection of this right.
