CERTIFICATE OF WATER RIGHT

This is to certify, *That* WILBUR J. PETERSEN

of 1527 E. 18th The Dalles, State of OR 97058, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well #4

a tributary of Fifteenmile Creek for the purpose of supplemental irrigation of 232.2 acres

under Permit No. G-9552 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 13, 1980

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.6 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 SE 1/4, Section 25, T1S, R13E, WM; 230 feet South and 470 feet West from E 1/4 corner Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with the rights perfected under Permits G-7869, G-8673, 44816 shall not exceed 2.6 cfs, the capacity of this system at the time of perfection of this right. and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
