of 2575 Fax Road, The Dalles , State of OR 97058 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Fifteenmile Creek for the purpose of irrigation of 66.9 acres and supplemental irrigation of 24.4 acres

under Permit No. G-8223 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.14 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the Lot 1 (SE 1/4 NE 1/4), Section 3, T1S, R14E, WM; 200 feet North and 1090 feet West from E 1/4 corner Section 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
