## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

PAUL LIMMEROOTH

of Route 3, Box 30, The Dalles, State of OR 97058, has  
a right to the use of the waters of Fifteenmile Creek

a tributary of Columbia River for the purpose of  
irrigation of 31.85 acres & stock

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 406; that the priority of the right thereby confirmed dates from 1893 for 9.15 acres & stock; 1896 for 20.4 acres; 1900 for 2.3 acres & stock

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.0 acre-feet per acre during the irrigation season of each year, if available at the original points of diversion in the NW 1/4 NW 1/4, Section 20; SE 1/4 NE 1/4, NE 1/4 SE 1/4, Section 19, T1S, R14E, WM; Marvel Ditch - 50 feet South and 1050 feet East; Lane-Smith Ditch - 2600 feet South and 120 feet West; \*

The point of diversion is located in the NW 1/4 NW 1/4, Section 20, NE 1/4 SE 1/4, Section 19, T1S, R14E, WM; 2000 feet South and 720 feet East from NW corner SW 1/4 SW 1/4, Section 17, T1S, R14E, WM; Boyd Mill Ditch - 3200 feet South and 1000 feet West from the NW corner Section 20.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

\*Boyd Mill Ditch - 3200 feet South and 1000 feet West; all from the NW corner Section 20

This certificate is issued to describe that portion of the prior right NOT cancelled under the provisions of an order of the Water Resources Director entered August 31, 1979, and is issued to confirm a change in place of use and points of diversion approved by an order of the Water Resources Director entered August 31, 1979 and describes the portion of the prior right NOT modified by the terms of said order, and supersedes the certificate recorded at page 5654, Volume 6, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

*And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
