## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

ROBERT E. AND BEVERLY JEAN TAYLOR

of 2084 Fisher Road, Roseburg, State of OR 97470, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Umpqua River

a tributary of Umpqua River for the purpose of irrigation of 0.66 acre

under Permit No. 28229 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.008 cubic foot per second; if available at the original point of diversion: SE 1/4 SE 1/4, Section 22, T26S, R6W, WM

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, as projected within McKinney DLC 47, Section 27, T26S, R6W, WM; 320 feet South and 600 feet West from NE corner Section 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to use of water is limited to the period when the flow of the North Umpqua River is more than 525 cfs at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.66 acre NE 1/4 NE 1/4 as projected within McKinney DLC 47  
Section 27  
Township 26 South, Range 6 West, WM

Being more explicitly described as within Lot 6, Trent Tracts.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered December 29, 1980, and together with certificates of water right recorded at pages 49901, 55663, 55664, 55665, 55666, 55668, Volumes 43, 51, State Record of Water Right Certificates, supersedes certificate 32648.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.*
