CERTIFICATE OF WATER RIGHT

This is to certify, That

FRANCIS A. KROUSE C/O KROUSE RANCH, INC.

of 15877 N. Applegate Rd., Grants Pass , State of OR 97527 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Cove Creek, Myrtle Gulch and Krouse Reservoir constructed under Permit R-5611

a tributary of Applegate River for the purpose of irrigation of 11.1 acres and supplemental irrigation of 4.0 acres

under Permit No. 34984 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 27, 1970

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.38 cubic foot per second; being 0.28 cfs from Cove Creek and 0.1 cfs from Myrtle Gulch and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4, NW 1/4 NE 1/4, Section 8, T38S, R4W, WM; Cove Creek - 1740 feet North and 560 feet West; Myrtle Gulch - 1370 feet North and 2575 feet West both from E 1/4 corner Section 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre—feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5611 and further limited to the use of water from Myrtle Gulch and Reservoir on the lands described as supplemental

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre SE 1/4 NW 1/4 10.1 acres NE 1/4 SW 1/4

SUPPLEMENTAL

4.0 acres NE 1/4 SW 1/4

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
