CERTIFICATE OF WATER RIGHT

This Is to Certify, That

SNOW CREEK IRRIGATION DISTRICT

of Bend , State of Oregon , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Three Creek, Snow Creek, and water stored under Permit R-701, in Big and Little Three Creek Lakes

a tributary of Squaw Creek for the purpose of irrigation of 28.3 acres and supplemental irrigation of 199.1 acres

under Permit No. 12458 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1923 for Snow Creek and Three Creek and September 12, 1936 * that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.88 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, Section 9, T17S, R9E, WM., from Snow Creek, NW 1/4 SE 1/4, Section 36, T16S, R9E, WM., from Three Creek and Sections 14 and 15, T17S, R9E, WM., from Reservoirs

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
