that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.53 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is NW 1/4 SW 1/4, Section 26, T2N, R27E, WM; located in the 1870 feet North and 1290 feet East from SW corner Section 26.

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be per acre. further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
