CERTIFICATE OF WATER RIGHT

This is to certify, That EDWARD T. HARRISON, JR

of 1681 Hammel Road, Eagle Point, State of OR 97524, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River and Lost Creek Reservoir constructed under Permit R-8142

a tributary of Pacific Ocean for the purpose of irrigation of 45.3 acres and supplemental irrigation of 10.0 acres

under Permit No. 47118 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 14, 1981 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.57 cubic foot per second and 80.0 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NW 1/4 NW 1/4), Section 4, T35S, R1W, WM; 650 feet South and 650 feet East from NW corner Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, provided further that the right allowed herein shall be limited to the use of stored water only on the lands described as supplemental, and is subject to the terms and conditions of Contract 1-07-10-W0289 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
