CERTIFICATE OF WATER RIGHT

This is to certify, That ROBERT G. SICARD AND SONS

of Route 1, Box 60, Boardman, State of OR 97818, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of waste water from West Extension Irrigation District

a tributary of Columbia River for the purpose of irrigation of 47.1 acres and supplemental irrigation of 84.8 acres

under Permit No. 46207 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 28, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.12 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 14, T4N, R25E, WM; 1310 feet North and 2140 feet West from Center 1/4 corner Section 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
