CERTIFICATE OF WATER RIGHT

This is to certify, That ROBERT L. STEVENSON

of 9003 W. Evans Creek Rd., Rogue River, State of OR 97537, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Brown Gulch, a spring and Stevenson Reservoir constructed under Permit R-5937

a tributary of Pleasant Creek for the purpose of supplemental irrigation of 3.5 acres and maintenance of fire suppression system

under Permit No. 36650 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 21, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.05 cubic foot per second; being 0.04 cfs from Brown Gulch and Reservoir for supplemental irrigation and 0.01 cfs from spring for maintenance of fire suppression system

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, NW 1/4 SW 1/4, SE 1/4 SW 1/4, Section 5, T35S, R4W, WM; Brown Gulch - 3110 feet North and 50 feet East; Spring - 2280 feet North and 200 feet East; both from SW corner Section 5; Reservoir - 1300 feet North and 870 feet West from S 1/4 corner Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and reservoir,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

fire suppression system & 1.5 acres SE 1/4 SW 1/4
2.0 acres SW 1/4 SE 1/4
Section 5
Township 35 South, Range 4 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
