## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROBERT B. POKORNY

of 8058 Pokorny Road NE, Woodburn , State of OR 97071 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Champoeq Creek

a tributary of Willamette River
irrigation of 8.0 acres

for the purpose of

under Permit No. 20868 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 14 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, as projected within Rhoades DLC 101, Section 14, 74S, R2W, WM; 1944 feet North and 68 feet West from SE corner Rhoades DLC 101.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 26295, Volume 18, State Record of Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered on April 24, 1981, approving transfer application 4670, and NOT canceled by orders of the Water Resources Director entered on February 11, 1981, and April 22, 1981 and together with certificate of water right recorded at page 50168, Volume 44, State Record of Water Right Certificates, supersedes certificate 26295.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
