## CERTIFICATE OF WATER RIGHT

This is to certify, That MILLER FORESTS

of PO Box 12395, Salem , State of OR 97309 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Pettijohn Creek with any deficiency in the available supply may be made up by appropriation from Willamette River a tributary of Columbia River for the purpose of irrigation of 8.5 acres

under Permit No. 48251 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed O.11 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Pettijohn Creek - SE 1/4 NE 1/4, as projected within Townsend DLC 47, Section 6, T8S, R3W, WM; Willamette River - NW 1/4 SW 1/4, as projected within Ekin DLC 51, Section 31, T7S, R3W, WM; Creek - 1510 feet South and 1270 feet West from NE corner Section 6; T8S, R3W, WM; River - 1360 feet North and 610 feet East from SW corner Section 31, T7S, R3W, WM. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres NW 1/4 NW 1/4 as projected within Townsend DLC 47 0.2 acre SW 1/4 NW 1/4 as projected within Townsend DLC 47 Section 5

2.3 acres NE 1/4 NE 1/4 as projected within Townsend DLC 47
Section 6
Township 8 South, Range 3 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
