of 24075 Klupenger Road NE, Aurora , State of OR 97002 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells 1 & 2 a tributary of for the purpose of Willamette River supplemental irrigation of 52.17 acres, related nursery uses, containerized nursery operation, and greenhouse nursery operation under Permit No. G-9846 and that said right to the use of said waters has been perfected in under Permit No. accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 31, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.23 cubic feet per second: being 0.65 cfs for supplemental irrigation, and 2.23 cfs for related nursery uses, containerized nursery operation, and greenhouse nursery operation, provided the total quantity of water diverted*

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is Well 1 - 260 feet North and 30 feet West; Well 2 - 150 feet North and 190 feet located in the

The amount of water used for irrigation, together with the amount secured under any other right one-eightieth of one cubic foot per second existing for the same lands, shall be limited to or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of and shall

perfection of this right, **
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**and shall be further limited to a diversion of not to exceed 1.0 acre-foot per acre for each acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein, together with the amount secured under any other right existing for the same land, shall not exceed 2.5 acre-feet for each acre irrigated in any one year. The use of water during the period from October 1 to March 31 as authorized here in shall not establish priority of right as against future appropriations of ground water for beneficial uses other than similiar rights for irrigation from October 1 to March 31, and shall conform to such reasonable rotation system as may be ordered by the proper state officer. The use allowed for supplemental irrigation may be made any time between October 1 and March 31 when water can be put to beneficial use by irrigation for immediate crop growth.
