of Route 1, Box 8, Dayton , State of OR 97114 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of West Branch of Palmer Creek

a tributary of Palmer Creek for the purpose of irrigation of 73.9 acres and supplemental irrigation of 7.5 acres

under Permit No. 43211 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.95 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, as projected within A. Smith DLC 48, Section 20, T4S, R3W, WM; 2180 feet North and 750 feet West from SE corner, DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the period from April 1 to September 30, and shall be further limited to a diversion of not to exceed 1.0 acre foot per acre for each acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein, together with the amount secured under any other right existing for the same land shall not exceed 2.5 acre feet for each acre irrigated in any one year.*
