CERTIFICATE OF WATER RIGHT

This is to certify, That W. J. PULLEN

of Route 2, Box 230, Bandon, State of OR 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Simpson Creek

a tributary of Coquille River for the purpose of irrigation of 3.0 acres, temperature control and flood harvesting of 2.2 acres

under Permit No. 46463 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 2, 1981

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.11 cubic foot per second; being 0.07 cfs for irrigation, 0.07 cfs for temperature control, and 0.11 cfs for flood harvesting

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, Section 21, T28S, R14W, WM; Diversion 1 - 610 feet South and 80 feet East; Diversion 2 - 400 feet south and 775 feet East; both from W 1/4 corner Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SW 1/4 NW 1/4 for irrigation
 0.6 acre SW 1/4 NW 1/4 for irrigation, temperature control, and flood harvesting of cranberries
 1.6 acres NW 1/4 SW 1/4 for irrigation, temperature control, and flood harvesting of cranberries
 Section 21
 Township 28 South, Range 14 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
