CERTIFICATE OF WATER RIGHT

This is to certify, That C. LOREN BOWMAN

of 18340 Hwy. 238, Grants Pass , State of OR 97526 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Applegate River and Applegate Lake Reservoir constructed under Permit R-7810

a tributary of Rogue River for the purpose of irrigation of 3.0 acres and supplemental irrigation of 9.52 acres

under Permit No. 45932 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 15, 1981

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.04 cubic foot per second for irrigation and 9.52 acre-feet stored water only for supplemental irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NW 1/4, Section 25, T38S, R4W, WM; New Berryman Ditch - 1050 feet South and 500 feet West from N 1/4 corner Section 25. (Applegate Dam - S 1/2 SE 1/4, Section 25, T40S, R4W, WM)

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 1-07-10-W0326 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
