## CERTIFICATE OF WATER RIGHT

**This is to certify, That** CITY OF UKIAH

of PO Box 265, Ukiah, State of OR 97880, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of City of Ukiah Sewage Lagoons, constructed under Permit R-6581

a tributary of Camas Creek for the purpose of irrigation of 38.1 acres

under Permit No. 41550 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 25, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, Section 13, T5S, R31E, WM; 1650 feet North and 3110 feet West from SE corner Section 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

In processing the application towards issuance of the permit, it appears that clerical errors were inadvertently made in limiting the duty of water to not\* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.3 acres NE 1/4 SW 1/4  
2.9 acres NE 1/4 SE 1/4  
27.9 acres NW 1/4 SE 1/4  
Section 13

Township 5 South, Range 31 East, WM

\*exceed 1/40th of one cubic foot per second per acre and 5.0 acre feet per acre, and in limiting the use to supplemental irrigation. In the issuance of this certificate, the duty of water has been reduced to 1/40th cubic foot per second per acre and 4.0 acre feet per acre for each acre irrigated during the irrigation season of each year, and the use described herein is declared to be for irrigation, in keeping with the customary policy and determination of this office of the proper maximum limits.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
