CERTIFICATE OF WATER RIGHT

This is to certify, That PRUDENTIAL LIFE INSURANCE COMPANY OF AMERICA

Superseded by Cert. No. 74704

of PO Box 3048, Pasco, State of WA 99302, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells #2, 3, 4, & 7

a tributary of Stage Gulch Basin for the purpose of irrigation of 879.31 acres and supplemental irrigation of 410.89 acres

under Permit No. G-4969 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 8, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

12.0 cubic feet per second, if available at the original points of appropriation in the NW 1/4 SW 1/4, Section 6 (Well 2), and SW 1/4 SW 1/4, Section 7 (Well 3), T3N, R30E, WM

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NE 1/4, Section 2, NW 1/4 NW 1/4, Section 12, T3N, R29E; NW 1/4 SW 1/4, Section 6; SW 1/4 SW 1/4, Section 7; T3N, R30E, WM; Well #4 - 180 feet North and 260 feet West from E 1/4 corner Section 2; Well #7 - 1010 feet South and 40 feet East from NW corner Section 12; Well #2 - 2010 feet North and 1330 feet East from SW corner*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

*Section 6; Well #3 - 1420 feet South and 40 feet East from W 1/4 corner Section 7.
