## CERTIFICATE OF WATER RIGHT

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 127; that the priority of the right thereby confirmed dates from 1873 for 19.8 acres; 1889 for 19.8 acres and 1900 for 77.4 acres that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.45 cubic feet per second, subject to the provisions of paragraph 33 of said decree and all other conditions and limitations contained in said decree

The point of diversion is located in the NW 1/4 SE 1/4, Section 22, T1N, R32E, WM; 700 feet South and 1800 feet West from East 1/4 corner Section 22.
