CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatRUSSMAR COMPANY, Jack Russell
c/o Cascade Cattle Company

1155 S. Fk. Little Butte Creek Rd
of Eagle Point, State of OR 97524, has made
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
Osborne Creek & Osborne Creek Reservoir constructed under Permit R-3424

a tributary of Little Butte Creek for the purpose of
irrigation of 15.5 acres and supplemental irrigation of 195.7 acres

under Permit No. 28973 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
August 1, 1963
that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
2.50 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the SW 1/4 SE 1/4, Section 26, NE 1/4 NW 1/4,
Section 25, T36S, R1E, WM; Creek - 20 feet North and 350 feet East from S 1/4
corner Section 26; Reservoir - 990 feet South and 1400 feet East from NW
corner Section 25.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated from direct
flow and shall be further limited to a diversion of not to exceed 4.5
acre-feet per acre for each acre irrigated during the irrigation season of
each year from direct flow and storage, provided further that the right to use
of direct flow shall be limited to the period when the flow of Little Butte
Creek is more than 31 cfs at its mouth and the flow of the Rogue River is more
than 1000 cfs immediately above Savage Rapids Dam, more than 1000 cfs at
Raygold, and more than 735 cfs at its mouth, and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right
is appurtenant, is as follows:
