CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PAUL AND NANETTE E. WEBER

of 30131 SW Mountain Road, West Linn , State of OR 97068 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River and 298.95 acre-feet from reservoirs constructed under Permits R-1625 and R-5363

a tributary of Columbia River for the purpose of irrigation of 41.5 acres and supplemental irrigation of 80.3 acres

under Permit No. 41611 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 8, 1977 for primary and June 1, 1977 for supplemental

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW 1/4 NW 1/4), Section 21, T3S, R1E, WM; 1150 feet South and 840 feet East from NW corner Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, and is subject to the terms and conditions of Contract 7-07-10-W0035 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
