CERTIFICATE OF WATER RIGHT

This is to certify, That MONA R. AND ALBERT L. MITCHELL

of PO Box 5896, Bend , State of OR 97708 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a spring and Applegate Lake Reservoir constructed under Permit R-7810

a tributary of Applegate River for the purpose of irrigation of 0.3 acre and supplemental irrigation of 3.3 acres

under Permit No. 46490 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 17, 1981

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second and 7.5 acre-feet stored water only from Applegate Reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 28, T39S, R3W, WM; Spring - 590 feet South and 500 feet East; River - 710 feet South and 600 feet East; both from Center, Section 28. (Applegate Dam - S 1/2 SE 1/4, Section 25, T40S, R4W, WM)

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoir, and is subject to the terms and conditions of Contract 2-07-10-W0446 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Supplemental from Applegate Reservoir 3.3 acres NW 1/4 SE 1/4
Primary from Spring 0.3 acre NW 1/4 SE 1/4
Section 28
Township 39 South, Range 3 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
