CERTIFICATE OF WATER RIGHT

This is to certify, That RALPH EASON

of Jordan Valley , State of OR 97910 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Owyhee River

a tributary of Snake River irrigation of 5.9 acres

for the purpose of

under Permit No. 15323 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

O.1 cubic foot per second; if available at the original point of diversion, SE 1/4 NW 1/4, Section 30, T31S, R42E, WM; 100 feet North and 1580 feet East from W 1/4 corner Section 30, and together with the amount diverted at the *

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NW 1/4, NE 1/4 SW 1/4, Section 30, T31S, R42E, WM; 100 feet North and 1580 feet East from W 1/4 corner Section 30; 1335 feet North and 2115 feet East from SW corner Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-sixtieth of one cubic foot per second per acre, and shall not exceed one acre foot per acre during any calendar month prior to June 1st, and three-fourths acre foot per acre during any calendar month after June 1st, of each year; and the total quantity diverted during the irrigation season from April 1st to October 15th, shall not exceed three acre feet per acre,

*original point of diversion shall not exceed 0.1 cfs and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.5 acres Lot 4 (SW 1/4 SW 1/4)

3.4 acres SE 1/4 SW 1/4
Section 30
Township 31 South, Range 42 East, WM

This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered January 24, 1977, and together with certificate of water right recorded at page 47634, Volume 40, State Record of Water Right Certificates, supersedes certificate 36152.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
