CERTIFICATE OF WATER RIGHT

This is to certify, That DONALD OAKS

of Box 44, Ironside, State of OR 97908, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Willow Creek for the purpose of supplemental irrigation of 198.3 acres

under Permit No. G-7389 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 8, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.6 cubic feet per second, being 0.86 cfs from Highway Well and 0.74 cfs from Nichols Well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NW 1/4, Section 28, SW 1/4 SW 1/4, Section 15, T14S, R39E, WM; Highway Well - 1160 feet South and 1200 feet East from NW corner Section 28; Nichols Well - 350 feet North and 250 feet East from SW corner Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event operation of these wells results in reduction of the natural flow of Willow Creek, water from said wells, in addition to that appropriated within the limitations of the duty of water as fixed herein, shall be discharged as ordered by the Watermaster into the channel of Willow Creek in the amount necessary to offset such reduction, and provided* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres NE 1/4 NE 1/4	28.4 acres Lot 2 (SW 1/4 NW 1/4)
21.0 acres NW 1/4 NE 1/4	34.5 acres SE 1/4 NW 1/4
35.8 acres SW 1/4 NE 1/4	26.0 acres NE 1/4 SW 1/4
4.0 acres SE 1/4 NE 1/4	31.4 acres Lot 3 (NW 1/4 SW 1/4)
4.6 acres NE 1/4 NW 1/4	9.2 acres NW 1/4 SE 1/4

Township 14 South, Range 40 East, WM

*further that the amount of water rediverted from the channel of Willow Creek shall not exceed the amount by which the flow of Willow Creek at the point of rediversion is increased above the natural flow of the operation by said wells.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
