CERTIFICATE OF WATER RIGHT

This is to certify, That GAYLE W. GILMOUR

of 1628 Sky Terrace SE, Salem, State of OR 97302, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of supplemental irrigation of 57.4 acres

under Permit No. G-3844 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 2, 1967 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.37 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 SE 1/4, as projected within Wood DLC 55, Section 23, T9S, R4W, WM; 580 feet North and 450 feet West from SE corner Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of appropriation approved by an order of the Water Resources Director entered August 3, 1977, and together with certificate of water right recorded at page 46236, Volume 38, State Record of Water Right Certificates, supersedes certificate 41007.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
