CERTIFICATE OF WATER RIGHT

This is to Certify, That W. H. H. DUFUR

of Portland, State of Oregon has a right to the use of

the waters of Ramsey Creek, a tributary of Fifteen Mile Creek (for Tracts Nos. 1 & 2) and Fifteen Mile Creek (for Tract No. 3);  
for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Wasco County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 7, at page 406; that the priority of the right thereby confirmed dates from 1861 (for Tract #1), 1866 (for Tract #2) and 1867 (for Tract #3).

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract #1 Seven (7) acres in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ); Two and six tenths acres (2.6 A) in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty-One (31); Township One (1) South, Range Thirteen (13) East of the Willamette Meridian, and One (1) acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Six (6), Township Two (2) South, Range Thirteen (13) East of the Willamette Meridian, being a total of 10.6 acres.

Tract #2 Five and five tenths (5.5) acres in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty-One (31), Township One (1) South, Range Thirteen (13) East of the Willamette Meridian.

Tract #3 Nine and five tenths acres in the Southeast Quarter of the Southeast Quarter of Section Thirty-one (31); Township One (1) South, Range Thirteen (13) East of the Willamette Meridian; Ten and nine tenths (10.9) acres in the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$ ) and Five and five tenths (5.5) acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Six (6), Township Two (2) South, Range Thirteen (13) East of the Willamette Meridian, being a total of 25.9 acres.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
