CERTIFICATE OF WATER RIGHT

of 10143 Silverton Road NE, Silverton , State of OR 97381 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well #2

a tributary of Pudding River for the purpose of irrigation and 45.6 acres and supplemental irrigation of 69.8 acres

under Permit No. G-8215 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.92 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 SE 1/4, as projected within Shaw DLC 51, Section 6, T7S, R1W, WM; 60 feet South and 1750 feet West from E 1/4 corner Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
