a tributary of Columbia River irrigation of 118.1 acres

for the purpose of

under Permit No. and that said right to the use of said waters has been perfected in 37975 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

April 13, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

1.48 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the River - Lot 8 (NE 1/4 SE 1/4), Section 22, T8S, R4W, WM; 1650 feet North and 300 feet West from SE corner Section 22. Reservoir - SW 1/4 NW 1/4, Section 7, TloS, R5E, WM

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 14-06-100-7776 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 3.3 acres Lot 8 (NE 1/4 SE 1/4)
