## CERTIFICATE OF WATER RIGHT

This is to certify, That

NICK KAMLADE (MORNING MIST DAIRY)

of 14380 Skelton Road SE, Jefferson , State of OR 97352 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of dairy waste water and reservoir constructed under Permit R-6644

a tributary of supplemental irrigation of 62.8 acres

for the purpose of

under Permit No. 41973 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 1, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.79 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, as projected within Johnson DLC 55, Section 36, T9S, R3W, WM; 1400 feet South and 700 feet West from NE corner Section 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

 $conform\ to\ such\ reasonable\ rotation\ system\ as\ may\ be\ ordered\ by\ the\ proper\ state\ officer.$ 

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.3 acres SW 1/4 SE 1/4 as projected within Johnson DLC 55 7.9 acres SE 1/4 SE 1/4 as projected within Johnson DLC 55 Section 25

14.6 acres NE 1/4 NE 1/4 as projected within Johnson DLC 55 19.9 acres NW 1/4 NE 1/4 as projected within Johnson DLC 55 12.1 acres SW 1/4 NE 1/4 as projected within Johnson DLC 55 Section 36 Township 9 South, Range 3 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
