CERTIFICATE OF WATER RIGHT

This is to certify, That DOROTHY M. BUTLER & MARVIN R. MANES

of Route 1, Box 1985, Bandon, State of OR 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a sump

a tributary of Coquille River for the purpose of supplemental irrigation of 19.6 acres and supplemental cranberry harvesting of 19.6 acres

under Permit No. G-7861 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 29, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second; being 0.34 cfs for supplemental irrigation and 1.00 cfs for supplemental cranberry harvesting

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NE 1/4, Section 20, T28S, R14W, WM; 605 feet South and 50 feet East from N 1/4 corner Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second, or its equivalent, for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

harvesting & 1.7 acres NE 1/4 NW 1/4
harvesting & 1.4 acres NW 1/4 NW 1/4
Section 20

harvesting & 3.0 acres SE 1/4 SW 1/4
harvesting & 13.5 acres SW 1/4 SW 1/4
Section 17
Township 28 South, Range 14 West, WM

*deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
