CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

DOROTHY M. BUTLER & MARVIN R. MANES

of Route 1, Box 1985, Bandon, State of OR 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Spring Creek and 3.0 acre-feet from Reservoir #1, constructed under Permit R-2240

a tributary of Coquille River for the purpose of irrigation of 0.5 acre, harvesting of 1.7 acres cranberries, supplemental harvesting of 13.4 acres cranberries and 15.1 acres frost protection under Permit No. 34762 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 5, 1969 for harvesting and frost protection and November 18, 1969 \* that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.32 cubic foot per second; being 0.01 cfs for irrigation, 0.09 cfs for harvesting of cranberries, 0.30 cfs for supplemental harvesting and 0.32 cfs for frost protection

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 20, T28S, R14W, WM; 800 feet South and 520 feet East from N 1/4 corner Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
